Nonaka Receives Japan Emperor's Award Former JAIMS Instructor Also Honored

On November 3, 2010, JAIMS President Ikujiro Nonaka received "The Order of the Sacred Treasure, Gold Rays with Neck Ribbon." The Order, established in 1888, is awarded to individuals for their merit and service. The Order consists of eight classes, and Nonaka's award -- The Gold Rays with Neck Ribbon – is of the third class.

"This is indeed a well-deserved honor for President Nonaka," said Blair M. T. Odo, JAIMS Executive Vice President and Chief Operating Officer. "The entire JAIMS 'ohana shares in the joy of this occasion and extends their warmest congratulations to him."

Nonaka is the recipient of many honors and awards including being named one of twenty most influential business thinkers by the *Wall Street Journal Online*. This prestigious Emperor's Award acknowledges Nonaka's valuable contributions as a citizen of Japan to the fields of management and leadership, which are studied throughout the world.

Mary Matayoshi was another with JAIMS ties who received the Emperor's award in November. In the early 1970s, Matayoshi taught English and American culture when the JAIMS American Management Program (AMP) was temporarily delivered in Hilo, Hawaii.


She is most fondly thought of by the students of the AMP 3 class (also known



JAIMS Receives Third \$5000 Grant from Berger Foundation

T he H.N. and Frances C. Berger Foundation contributed \$5000 in December 2010 to the Senator Francis A. Wong Leadership Award scholarship fund, marking the third such grant in the past two years.

Established in 1988 by JAIMS Trustee Wong, the Award recognizes a student from each class for "promising entrepreneurial skills, high ethical standards, and a respect for ethical behavior as evidenced by demonstrative initiative and leadership qualities."

"The Berger Foundation's continuing support of this most prestigious Award enables JAIMS to recognize the students who exemplify the leadership qualities that Mr. Wong believes are most valued," said Dr. Blair M.T. Odo, JAIMS EVP/COO.

Since the establishment of the Award, 49 students have been honored. The recipient of the Fall 2010 East-West Knowledge Leaders Program (EWKLP) is Venkata Ram Kumar Bokka of India, and the recipient of the Japan-focused MBA 2009-2011 class is Kesson Yamamoto of Hawaii.

Wong is the Founder and Chairman/CEO of Genesis Hotel Development Ltd., a leading provider of corporate hotel development. He is a former Hawaii State Senator, and his distinguished career includes law, finance, real estate development, and urban planning. He is also a member of the Board of Directors of the H.N. and Frances C. Berger Foundation.

The Berger Foundation's long-standing philanthropic work supports organizations, particularly in healthcare and education, which empower people to achieve their goals.

JEMBA 2009-2011 Students Intern in Tokyo

A fter completing 18 months of study in Honolulu, the 10 students of the 2009-2011 Japan-focused MBA (JEMBA) class began their three-month capstone internships at various organizations in Japan in January.

Internship organizations include Capital Services Group, Deutsche Securities Inc., EMC Japan K.K., Gracchus & Associates, Inc., Japan Market Resource Network (JMRN), Medtronic International, and Reebok Japan.

JEMBA is a cooperative program between JAIMS and the University of Hawaii Shidler College of Business. The internship was preceded by course work in Honolulu consisting of core MBA classes, advanced level international business courses, and intensive business Japanese language and culture lessons.



EWKLP 2010F Graduates Encouraged to Ask Whether They Would Hire Themselves

On January 6, JAIMS bid aloha to the 20 students of the East-West Knowledge Leaders Program 2010 Fall term. Blair M.T. Odo, JAIMS Executive Vice President and Chief Operating Officer urged graduates to list the knowledge, skills, and values they desire of their employees, and -- given these desirable traits -- ask would they hire themselves? She reminded them of JAIMS President Ikujiro Nonaka's emphasis on phronetic leadership, where leaders exercise practical wisdom and sound judgment for the common good -- not simply for the bottom line.

At the Closing Ceremonies, Venkata Ram Kumar Bokka of India received the Senator Francis A. Wong Leadership Award. Won Tae Lee of Korea received the Students' Choice Award for being a "Smart Classmate/Smart *Oppa* (Big Brother)." Carissa Caparas of the Philippines was also recognized by her peers for her dedicated support.



The EWKLP 2010 Fall class was composed of students from 11 countries (Australia, China, Hong Kong, India, Indonesia, Japan, Korea, Malaysia, the Philippines, Taiwan, and Thailand). The 3-month EWKLP is held twice a year, from April to July and from October to January.

Winning Model Seeks to Sustain Innovation, Eyeing Africa for Fujitsu Mobile Phone Business

EWKLP 2010F students Tomoko Kusunoki (Japan), Won Tae Lee (Korea), Akihiro Terada (Japan), and Jiawei Wang (Taiwan) received the President's Award for their Model for Innovation, *Discover a New World with Fujitsu Mobile*. The team's model explored the problem of sustaining innovation within a company. The team drew on the successes of Samsung to enhance the possibilities of Fujitsu Limited and suggested that Fujitsu look to Africa to expand their mobile phone business. The competition, held on January 5, featured five student teams that presented models on diverse topics.

The second place award went to Nalini Asfaroyani (Indonesia), Venkata Ram Kumar Bokka (India), Chihiro Morioka (Japan), and Shan Shan Kwok (Hong Kong) for *Tobacco: Exploring the Future*, a model focused on finding an alternate use for tobacco in the United States. The team proposed that tobacco could be used as organic pesticides in fish farming. The remaining teams, each receiving an honorable mention, presented models on regaining organizational reputation as an innovation leader; on revitalizing interest in *Kabuki* by positioning the theatrical art form domestically and internationally; and on developing a mobile multimedia library to bridge corporate sponsors interested in educating those in poverty-stricken communities in Indonesia and the Philippines.

The EWKLP Model for Innovation Competition is the culminating project of the EWKLP, which requires students to develop a solution, via a new business model, for solving a real-world business or social problem. Preparation for the Model for Innovation Competition began during the third week of the program. All student teams received coaching by business executive Thomas Ueno, proprietor of Thomas T. Ueno CPA.

The Weissman scholarship – administered by JAIMS under the auspices of the Rotary Club of New York – is given to a deserving JEMBA student who will undertake an internship in Japan in international public relations, marketing, or advertising.

The scholarship honors the late Norman Weissman, who enjoyed a distinguished career in international public relations and who mentored many public relations professionals, and honors the close connections Weissman developed between the United States and Japan.

Although a connection to New York is not a criterion for scholarship eligibility, Coremin graduated from New York University and worked in New York until joining the JEMBA program in 2009.
