Knowledge Cafe: Dods, Kobayashi, Nonaka Discuss "The Wise Leader"

The JAIMS-sponsored Knowledge Café on May 1 featured a "talk story" discussion on "The Wise Leader" among Walter A. Dods, Jr.; Saburo "Sam" Kobayashi; and Ikujiro Nonaka -- three individuals recognized for their contributions to the study and practice of leadership.

Nonaka, named one of 20 influential business thinkers by the *Wall Street Journal Online*, serves as JAIMS president. A prominent leader

in the Hawaii community, Dods serves as JAIMS Trustee, and is Chairman of the Board of Alexander & Baldwin, Inc. and Mid Pac Petroleum, LLC. Kobayashi was an engineer at Honda R&D, where he developed the airbag safety system in Honda cars. Kobayashi lectures internationally on creative innovation.

The three shared many nuggets of wisdom. Among them was the importance for leaders to get to the frontline – what Nonaka refers to as "actuality" – and use one's senses to know and truly feel the issue.

After going to the frontline, leaders should form cross-functional teams for diversity of knowledge, as Dods did during his many years as the head of First Hawaiian Bank. According to Nonaka, dialog is important but then the leader must stop and take action.

In response to Nonaka's assertion that leaders must use their senses to understand actuality, Dods quipped, "Common sense is not so common." Based on experience, Dods noted that many leaders, once attaining high-levels in their career, "lose their hearing" and stop listening to others. Another sensory issue of many leaders is the "eye-problem" ("I" problem), where leaders take credit for everything, and these pitfalls can curtail one's career, he said. Instead, leaders need to nurture others to grow, he advised.

Kobayashi added that the use of the five senses in business is important to explore and address the invisible essence (or the real cause, need, or want) that is behind the reality. When looking for ways to innovate, Kobayashi advised the audience not to ask the customers what they want because the customers do not necessarily know. Instead, he suggested that the audience carefully watch their customers – evaluating details at the frontline, as Nonaka suggested – to ascertain what customers value.

Innovation requires imagination supported by a noble vision, Kobayashi said. Nonaka's Wise Leader framework published in the May 2011 issue of the *Harvard Business Review* details the six characteristics of *phronetic leadership*, which is leadership for the common good. Dods concurred that profits cannot be the primary motivation of an organization.

The trio also discussed risk-taking, suggesting that leaders must take risks and learn from failure. Nonaka noted, "Without practicing, we cannot jump." According to Dods, making mistakes is an essential requirement for learning and leading. The caveat however, is that it is important to first build a solid reputation and a good track record.

Addressing the JAIMS students in attendance, Dods said, "Don't take the most radical step on the first day. Once people have confidence in you, you can stretch and have the courage to get outside the box and do unusual things." In terms of innovation, he said, "There's always something new that can be created."

The JAIMS Knowledge Café is a lecture series that offers the perspectives of leaders who have transformed their organizations by effectively leveraging knowledge.

2010-2012 JEMBA Class Graduates in Tokyo

AIMS, with its partner the University of Hawaii Shidler College of Business, recognized the six students of the 2010-2012 Japan-focused MBA (JEMBA) class at commencement ceremonies held at the Josui Kaikan in Tokyo on April 17.

Over the past two years, the students' rigorous program consisted of core MBA classes, advanced level international business courses, and intensive Japanese language and culture lessons. A 3-month internship in Tokyo served as the capstone experience for each student.

This year's internship partners were Fujitsu Limited, Integrated Products Division; Fujitsu Limited, Global Partner Alliances Division; Fujitsu Limited, Global Portfolio Planning Office; Kyoto Obubu Tea Plantations, LLC; Motherhouse Co., Ltd.; and Reebok Japan.

Commencement speaker Professor R. Taggart Murphy of the University of Tsukuba reflected on the nuclear accident at Fukushima, which he views as a political, not technical problem.

JEMBA graduate Olivia Wong, who delivered the



student address on behalf of her cohort, shared how a recent trip to Cambodia encouraged her to pursue a career in social business via the fashion industry. She challenged her classmates to engage in social change regardless of their industry.

Winning Model Seeks to Improve Japan Childcare in Partnership with Train Companies

EWKLP 2011F students Kimitaka Ishida (Japan), Lam Mac (Vietnam), Taku Ono (Japan), and Jarupa Watpragairat (Thailand) received the President's Award for their Model for Innovation, Railway to the Future. The team's model addressed the difficulty of raising children in Tokyo due to limited nursery care options and suggested ideas focused on parents who must transport their children on the way to work.

As the culminating activity of the EWKLP, the competition featured six student teams that developed a solution, via a new business model, to a business or social problem.

The second place award went to Kanya Cittasthira

(Indonesia), Shingo Inoue (Japan), Takeshi Ito (Japan), and Jieun Lee (Korea) for *Links: We Connect You*, a model focused on providing services to help those with limited access to supportive communities. To illustrate their model, the team used the obstacles faced by international students who study in Hawaii.

The third place award went to Carlo Abas (Philippines), Syarein Abu Samah (Malaysia), Sachiko Otsubo (Japan), and Shigeki Yamanaka (Japan) for Report on Photosynthesis of Happiness: Authentic Change of Management, a model that demonstrated how nurturing and empowering employees could lead to increased sales and profitability.

EWKLP 2011F Graduates Encouraged to be "Wise Leaders"

On January 5, JAIMS bid a fond farewell to the 23 students of the EWKLP 2011 Fall term. Dr. Blair Odo, JAIMS Executive Vice President and Chief Operating Officer



Seminar Participant Explores Business Skills, Hawaii Culture

Editor's Note: This is an excerpt of an article written by JAIMS seminar participant Toshiko Miyairi, who attended the one-week Global Skills Refresh Program (GSRP) at JAIMS in October. The 2012 GSRP -- a seminar open to all -- is scheduled for December 3-7, 2012.

pon moving from Waikiki to our homestays, we all received a wonderful warm reception. [In the GSRP], we studied presentation, negotiation and critical thinking, all using English. We were encouraged to analyze the type of leader we see ourselves as. During the Downtown field-work activity, we talked about Hawaiian culture, economy, politics, history, and home customs. Then we broke into teams to explore the downtown area. After going home each day, we had a lot of homework to do during our free time; usually early in the morning or after midnight.

During "Coffee Talk" each morning, we talked about

"the metaphor for your life," "a defining moment in your professional life," and "in ten years I expect...". These impromptu sessions were a useful tool for introducing ourselves and getting to know the other members.

The people of Hawaii have a huge range of cultural backgrounds and language. Many locals spoke to us quietly and gently in English. We received useful and interesting instruction, which allowed us to smoothly communicate. I think we all benefited from learning how to exchange significant opinions with the European and American participants while breaking out of the culture circles we may have started the class in. I recommend participation in external training, such as JAIMS, that provides opportunities to mix with students and teachers from other countries and cultures. The rewards might surprise you.
